**NOTIFICATION**

NO.BPPRA/FIN/CMS-1/2026/ 1045-62. In continuation of this office's earlier Notifications No. BPPRA/Admn/1-30/9561-70 dated 05<sup>th</sup> September 2023 and No. BPPRA/FIN/CMS-1/2025/9032-41 dated 26<sup>th</sup> June 2025, and in compliance with the decision taken in the 16<sup>th</sup> Meeting of the Board of Directors of BPPRA held on 18<sup>th</sup> September 2025, the Authority notifies that the **Tender Uploading Fee** previously being collected from the Procuring Agencies is hereby **withdrawn** with effect from 23<sup>rd</sup> January 2026.

2. Effective from 23<sup>rd</sup> January 2026, a **Tender Participation Fee** shall be applicable to and payable by the Contractors, Vendors, General Order Suppliers, etc., for each tender in which they participate. The fee shall be charged at the following rates:

Tender Amount	Tender Participation Fee
Up to Rs. 5 million	Rs. 1,000
From Rs. 5 million to Rs. 250 million	Rs. 1,500
From Rs. 250 million to Rs. 1 billion	Rs. 2,000
Above Rs. 1 billion	Rs. 5,000

3. It is further clarified that the **Tender Cancellation Fee** shall continue to be payable by the Procuring Agencies. **Supplier Registration Fee** and **Annual Subscription Charges** shall be paid by the Contractors, Vendors, and General Order Suppliers, as per the rates previously notified by this Authority vide notification dated 05<sup>th</sup> September 2023.
